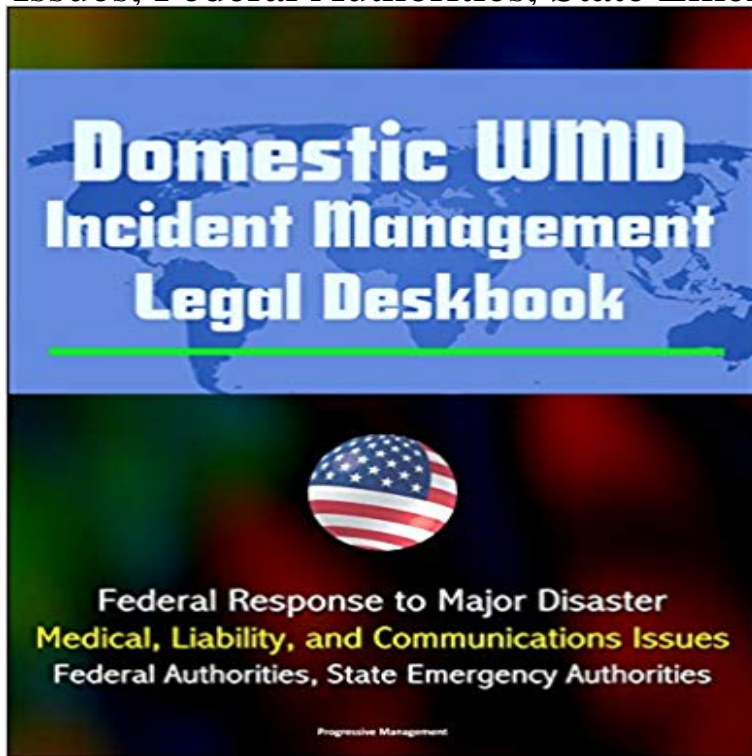

To our knowledge, this is the first publication of its kind. It is designed as a research tool for lawyers responding to weapons of mass destruction accidents or incidents of terrorism. The purpose of this Deskbook is to identify legal authorities available to Executive Branch Departments and Agencies responding to a WMD event involving terrorism or an accident.
